## 1 ATTENDANCE

#### 3 MINUTES OF PREVIOUS MEETING AND MATTERS ARISING

The minutes of the full council meeting held on 4<sup>th</sup> October 2021 were AGREED and signed by the Chair.

The minutes of the full council meeting held on 8<sup>th</sup> November 2021 were AGREED and signed by the Chair.

## 4 APPROVAL OF DECISIONS FROM MEETING NOVEMBER 8th 2021

The Council reviewed each item discussed at the meeting on November 8<sup>th</sup>. All points discussed were AGREED on the basis of the published minutes.

The application for planning permission for traders at Hoveton Village Hall was AGREED with a figure of £240 noted.

The Terms of Reference for the Planning Committee was AGREED as discussed.

The Volunteers Policy was AGREED as discussed.

## **5 PUBLIC FORUM**

There were no public present and no reports to receive.

## 6 PLANNING

- 6.1 PF/21/2644 Councillors discussed the application at length. The agreed response was as follows:
  - "Hoveton Parish Council strongly objects to the application owing to the unsuitable nature of the access along Long Lane. The Transport Statement submitted with the application suggests a possible 25% increase in traffic flows along a rural lane which is well used by pedestrians and cyclists, including those from cycle hire facilities on the Bewilderwood site. The mix of vehicles will also change, with an increase in commercial and service vehicles accessing the site. The Council feels that the highway infrastructure is highly unsuitable and threatens the use of Long Lane for recreation by local residents."
- 6.2 PF/21/2561 Councillors SUPPORT this application.

#### 7 ACCESSIBLE PLAY EQUIPMENT

7.1 The application was AGREED by councillors. It was noted that the additional funds (beyond those available from the grant) need to be found, hopefully from S106 monies, and that there is nothing budgeted for this from the Parish Council finances.

## 8 FINANCE

- 8.1 The items of expenditure (as noted in the Schedule of payments issued for the meeting on November 8<sup>th</sup>) were AGREED.
- 8.2 Councillors discussed the payment of wages for the Clerk of Hoveton Village Hall. It was unclear what had been agreed previously about the intended total spend for this, as the minutes of the meeting where the item was discussed don't record this. It was agreed that the Village Hall Sub-Committee should discuss the matter again and come back to the Parish Council with a proposal.
- 8.3 The Clerk's expenses (mileage) were AGREED.

9.1 The next meeting of the Council will be on December 6<sup>th</sup> 2021. It will be held in the Village Hall at 7:15pm.
